The Evening's Presentation, March 12, 2015

Steve Gabeler - "The Desert Fix - Southeast Utah on Foot"

Gabe presented a spectacular set of images created on a recent hiking and driving trip to southern Utah. Locations included Zion, Capitol Reef and Bryce National Parks, as well as the Escalante Basin, Valley of Fire State Park, and various locations along Utah Highway 12, one of the most spectacular scenic drives in the country. Particularly interesting were many photographs of multicolored and textured patterns in the sand and on rock surfaces created by mineral deposits, lichens, and the leaching of minerals out of the ground.

Gabe shot with a Pentax K5 and a single lens – an 18-125mm (27-190 35mm equivalent) zoom.
