INCLUDING MINUTES OF THE MAY 12, 2016 MEETING

Wayne called the very well attended meeting to order with a minimum of business. On June 9 Hendrik will continue his technical presentation, "Photoshop for Nature Photographers." Some of the topics remaining include high dynamic range processing (HDR), panorama stitching and various blending modes. Ed McGuirk has stepped up for July 14 with a program dealing with Alaskan Grizzlies.

New Show at United Parish of Auburndale

SVNP has been invited to return to UPA to hang a show. The show will run from July 18 through mid-September. Carol Walsh again will organize the show – the announced theme is "The Nature of New England." The date for the opening reception has been tentatively set for early evening, Friday, July 29, 2016.

The Evening's Presentation - Jake Mosser

The evening's presentation by Jacob Mosser, III was titled, "Locations in N. E. Massachusetts, with Techniques and Equipment." In describing the genesis of the program, Jake said he started by considering images in folders with titles such as "Yellowstone" and the like and quickly came to the conclusion that some tightening needed to be done. Consequently, he lit on the concept of starting small (photography in his own backyard) and moving away by degrees, but not so far afield as some of the more popular destination photo locations. He also described himself as interested in the full spectrum of nature photography. That would include the popular critters (foxes, snowy owls, etc.), to landscapes, to mushrooms and to bugs. That range requires a similar expanse of equipment: 500mm telephoto, tele-extenders, macro lenses and extension tubes, flashes, circular polarizers, tripods, gimbal heads, cable releases, self-timers, lions and tigers and bears, OH MY! OK, I lied, no felidae or ursidae, still, as the man said, a Lot of Stuff. The introductory slide enumerated nearly all the necessities of the trade: Love of Nature, Patience, Persistence and Camera Equipment. Those, as well as Luck. Lady Luck, as in, "If you want it to be there every time, take up architecture." The rest of the program was filled with bits of hard information about gear and techniques as well as the locations.

The photos from Jake's back yard included violets with droplets from a recent rain, the droplets accentuated with flash, iris, insects, a bluejay on a landing stick staged conveniently to both the bird feeder and the kitchen window as well as the new normal, turkeys.

Ipswich River Town Park in **North Reading** yielded images of geese directly after a snowfall (with snow starting to slough off the trees in a dramatic sheet), a valuable demonstration of depth of field using some milkweed, a demonstration of pre-focusing showing a bee approaching a flower as well as a demonstration of fill flash via two photos of a cardinal flower.

Next came the turn of **Harold Parker State Park** in **North Andover** to shine. Included in the photos were several of lady slippers. The lighting of one gained interest when it was revealed that the dark background was enabled by Jake's ability to use his own shadow, thanks to the camera's self-timer. The circular polarizer came in handy with a shot of water lilies, damping specular highlights on the leaves and the water. The use of a reflector to fill and modify light was also discussed.

The point was made that compositing is not sanctioned in nature photography and that edits must be made with zero or minimal impact on the story, as opposed to the presentation which, it is assumed, will be optimized within the bounds of reality.

Next up, we were treated to osprey somewhere on the Saugus River, including a nest on a utility pole in the vicinity of Mike's Roast Beef.

Great Meadows NWR in **Concord** yielded a great many critter shots: redwing blackbird, marsh wren, woodpecker, hooded merganser, among others as well as a remarkably human-tolerant great blue heron. In an aside, Jake discussed the use of exposure compensation in preserving detail in light-colored flowers.

Parker River NWR (Plum Island) in **Rowley** yielded some photos but the area is essentially off limits during the plover nesting season.

Not too far away, though, **Sandy Point State Reservation** in **Ipswich**, seems to be more lenient in providing access. Still, visitors are required to walk below the tide line. There were some fine pix of shorebirds including one of a mass of fluff in raking light seemingly supported by at least three pair of legs.

From the **Mass Audubon Ipswich River Wildlife Sanctuary** (accessed from **Topsfield**) came some photos taken at bluebird boxes including a series involving a sparrow getting a nasty surprise while making an uninspired attempt to investigate an already occupied box.

At the **Salisbury Beach State Reservation** in **Salisbury** we were treated to several photos of snowy owls as well as others of foxes.

An after-presentation discussion covered a great deal of ground, from camera preferences to tripods, to settings for birds in flight. The crowd gave Jake a hearty round of applause for an evening that was both informative and enjoyable.
