April 12

## **April Presentation – Member Images Night**

**Sue Abrahamsen** showed several images that she felt belied the real nature of the subjects. She also showed one utilizing intentional camera movement.

**Wayne Hall** showed photographs that concentrated on reflections. The locales included Gray Reservation and Puffer Pond.

**Ed McGuirk** displayed several examples of intentional camera motion in which the motions were judged to the desired effect and not necessarily linear. He also showed some multiple exposures done with different approaches.

Hendrik Broekman showed several approaches to using blur and some further possibilities for processing or compositing.

**Barbara Peskin** showed some fine bird images as well as one of her dog, Oliver.

#### **May Presentation**

**Shawn Carey** gave a fascinating talk entitled, "Tanzania – A Photographer's Journey". The program was drawn from a trip, Shawn's first to the region, taken in January 2017. This is outside of the dry season so the large herds are not so evident. Still, Shawn showed a wealth of species, too long to start naming here.

The first official stop on the trip was in Tarangire National Park through which the Tarangire River runs, creating a dry-season concentration. From there, the trip led to Lake Manyara where it was possible to see several species of water birds, including lesser and greater flamingos,

Next on the itinerary was Ngorongoro Crater. The crater covers about 100 square miles, which suggests a rim of about 11 miles in diameter. It is a formidable physical barrier and, as a consequence, some species such as impala and giraffe are not found in the crater and the lion population is significantly inbred, as well. There are still plenty of animals to see including two very large birds, the Kori Bustard and the Secretary bird.

Outside the crater but still within the Ngorongoro Conservation Area is the Ndutu Lake area. Here are found several large birds, including Rueppel's Griffin Vulture, which has been confirmed to fly at altitudes comparable to passenger jets. Among the many mammals shown, the cheetah made its first appearance in the show here. Traveling on to Serengeti National Park, Shawn's group was able to photograph a leopard and her two cubs as well as a plethora of vehicles filled with folk trying to pull off the same feat.

Shawn was generous with tips for both photography as well as the interpersonal and cultural aspects of engaging in ecotourism in Africa. At the end, the well-attended room was enthusiastic in its appreciation.
