Quoting from Wayne's note of July 9: "We've decided that the theme for our upcoming semi-annual 'member images night' on August 8 will be "shapes" (suggested by Katherine O'Hara). The idea will be to choose a geometric shape (circle, triangle, S-curve, spiral, etc.) and base all of your (up to five) images on that one shape....Let the creative juices flow."

Featured presentation notes:

Vivienne Shein gave a beautiful presentation on "Photographic Opportunities in the St. Augustine area," the result of her trip to Florida in February with husband Norm – to beat the winter of New England. She particularly likes that part of Florida because there is a such a great variety of subjects to photograph, and she showed us a large sampling of all of them – architecture, historical buildings, forts, lighthouses, shops, people, birds (a particularly gorgeous and proud white peacock), animals.

Vivienne used a Canon Rebel XSI with a 70-300 and a wide angle lens. Yes, she used a tripod for many of her shots. She recommends this area highly. It has more character and, is easier to get to, and is not so expensive as other areas of Florida.

Member images:

Katherine O'Hara showed images of Florida birds, Ibis, little blue heron, Great Horned owl.

Sue Abrahamsen showed before and after shots of images taken at a pond near the MetroWest Medical Center -- lotus blossoms, frogs, dragonflies.

Marilyn Tromer showed photographs of owls taken during a presentation at the Sudbury Library, dragonflies and damsel flies and other insects from a recent walk at Carlisle Conservation areas.

Directions to Newbury Court, 80 Deaconess Road:

Newbury Court is located next to Emerson Hospital, in Concord. To reach us from I-95 or route 126, go west on Route 2, turn left or south at the stoplight just after the hospital onto Old Road to Nine Acre Corner (ORNAC).

Turn left onto, *Deaconess Road. There is parking in a lot to the right as well as designated areas along Deaconess Road. Park anywhere that is not designated as a no-parking area and walk to the portico into the north entrance of Newbury Court. The Community Room is right off the lobby.

Another route to Newbury Court from the south is via Concord Road and Sudbury Center. Stay north on Concord Road past the Lincoln-Sudbury High School. Turn right on Sudbury Road. Continue past Nashawtuc Country Club, through the light at Dunkin Donuts, to ORNAC Road, the second left after Verrill Farms. Go north on ORNAC past Newbury Court Road to Deaconess Road. Turn right and follow directions from the *.

Note: There are two entrances to Newbury Court: one at the end of Newbury Court Road and one at the end of Deaconess Road. The entrance at Deaconess Road takes you closest to the Community Room.
