INCLUDING MINUTES OF THE JULY 11 MEETING

Due to a renovation being done in the Community Room at Newbury Court, July's meeting was held in the Great Room (at the other end of the complex.) Rather than using the projector, the presentation (which was made up of a series of 10-second audio/video clips) was given (via an HDMI connection) on the wall-mounted TV. The attendees were so impressed with the quality of the color display ("It looks as good as the laptop," "It's no different than on my monitor at home") that the decision has been made to change all further meetings to the Great Room, at least until a similar or better display somehow appears in the Community Room.

Referencing the work being done in the community room, Betsy Moyer suggested that not only has it become time to completely refresh the group display but that, in the interim (or until another space becomes available for display), some exhibitors might wish to take prints home.

## The Evening's Presentation

New member Susanna Kamon presented a fascinating program titled *Using Trailcams to Discover The Prevalence and Behavior of Wildlife In Our New England Woods.* After attending a presentation on the use of trail cameras, Susanna became intrigued with the possibilities for observing and understanding the local wildlife in Concord, MA. As she got into it, her larger project became to observe wildlife, especially bears, in southern New Hampshire. As she explained, simply setting up a trail camera hardly guarantees success. Issues of finding well-used habitat as well as managing light, sight lines, and any potential conflict with the native animals the presence of the camera may cause must be addressed. For instance, while coyotes

mostly ignore the cameras, bears do investigate and, if placed too high, have been known to scratch them down.

Having scouted for activity and identified a likely locale, Susanna was rewarded with images of coyotes, both in daylight and after dark. As her sightings increased, she was able to start identifying resident individuals as well as likely transients. As the sightings increased further, Susanna could begin to discern from them an outline of their group dynamics.

The attendees found the presentation both intriguing and stimulating. Many questions about both logistics and animals were asked which Susanna answered in satisfying detail. As a consequence of the room's enthusiasm for Susanna's subject, much was left to be shown. This will take place at the December 12 meeting. Be there!

Viewing took place in the Elqui Valley which markets itself as the prime astrophotography location in Chile. After the eclipse the group traveled around the Atacama Desert seeing the sorts of sights not often granted to New Englanders.

Ed McGuirk displayed a series of fine images devoted to the springtime colors of New England. There were some images from Massachusetts but many more from northern New Hampshire.

Hendrik Broekman showed a series of photos of local plants and wildlife, with a concentration on our recent wet spring.
