The news here is that, as of the beginning of December 2015, the bulk of the site has become available only by subscription. The good news is that the cost is eminently reasonable: \$12US/year. There is not much to be learned about digital photography that is not contained on the site. Video courses, which were sold before are now available to subscribers for no extra charge. This is a bargain. The site founder, Michael Reichmann, has an article on a recent trip to the Afar region of Ethiopia, which lies in front of the login (a complimentary article, as it is styled), which should give a good impression of the quality of the goods within.

The Evening's Presentations

Bob Diefenbacher presented three subjects. The first two, images from trips to the Galapagos and some of the Utah Canyonlands, were presented on DVD as music-accompanied slide shows, which Bob narrated live, taking questions as the presentation progressed. The trip to the Galapagos was jointly organized by National Geographic and Lindblad, while the Utah trip was a product of Arizona Highways Magazine. In view of and despite his disclaimer before the Galapagos portion, a large proportion of those images were fine examples of wildlife photography. He even managed to stalk a few wily tourists on the hoof. As expected the Utah images tended more to landscape and were equally fine.

On both these trips he used his Canon DSLRs, which raises Bob's third subject: his subsequent abandonment of the larger cameras for mirrorless interchangeable lens cameras, specifically the Olympus OM-D E-M1 micro four thirds system camera. The group was provided a sheet that Bob compiled, detailing what he considers the important differences between the two regimes, both pro and con. This section provided a welcome excuse to simply talk gear, something in which the whole room engaged with gusto.

Member Images


