### Member Images

Due to a scheduling snaffle, the meeting started with member images.

Hendrik Broekman showed several images taken in the autumn of this year, the selection weighted toward small wildlife.

**Ed McGuirk** presented a collection of landscape images, one for each month of 2017.

Wayne Hall offered images from Stearns farm in Framingham as well as Heritage Park in Sudbury. He finished with a shot of ginkgo *F* leaves in fall (taken in his front yard) as a demonstration of

**Sue Abrahamsen** showed a sequence of images of a crab spider dispatching a bee on a thistle bloom. The bee never stood a chance.

**Terri Ackerman** showed images from the macro workshop led in November by Ed McGuirk.

### The Evening's Presentation

SVNP member **Bob Diefenbacher** presented two short videos, made with ProShow Gold. The first, "A Photo Workshop in Southwestern Utah" consists of images of Arches and Canyonlands National Parks in early fall taken during a 7-day photo workshop sponsored by Arizona Highways Friends of Photography. Bob produced this video in 2009, using an earlier version of ProShow and assembled it manually.

"Yosemite in Winter" features images made during a Tauck Event in San Francisco and Yosemite at Christmas time. The event allowed Bob to capture images of interesting spots in San Francisco, Muir Woods, the Awahnee Hotel in Yosemite, and Michael Adams, son of Ansel. Even though he and his wife attended, Bob could not photograph the renowned Bracebridge dinner at the Awahnee, which takes place under a photo embargo. The newest version of ProShow Gold offers a facility to automatically assemble a show. Bob chose to give it a try and displayed that result. The room seemed to share Bob's feeling that, left to its own devices, the program struts its stuff (as in, if you've got it, flaunt it) and produces too busy an effect, one more appropriate to a pre-presentation time filler than the presentation, itself. Apparently, exercising art in judging flow and context still counts for something.

Bob also presented two brief PowerPoint sequences. The first detailed the general workflow associated with ProShow Gold. A conversation ensued that included input from Sue Abrahamsen and Ed McGuirk, both of whom also use ProShow. For information about ProShow, visit photodex.com

The second was an encomium for On1 Photo Raw 2018, which Bob has adopted out of personal frustration with Adobe Lightroom. According to Bob, with a lapsed CC subscription, one loses the Lightroom Develop module but no other. So the digital asset management (DAM) capabilities would seem to be preserved. This makes it possible to consider using programs such as On1 as developing plugins while preserving the other functions of Lightroom.
