The Evening's Presentation

Terri Ackerman presented a program largely of photos taken in Malawi on an eleven day stint as a volunteer with EarthWatch. The major and ongoing effort is one of repopulation of native and endangered wildlife in an area that had been poached nearly empty by 2000. The volunteers largely acted as force multipliers in the task of census taking. From sweeps conducted from moving vehicles, to monitoring watering holes as well as servicing camera traps, the volunteers got to see a lot of the mundane stuff that contributes to the restoration magic.

Between assignments assisting researchers at the Majete Wildlife Reserve, Terri had rather close access to some of the most iconic African fauna. Too close, in some ways, having to be watchful of creatures from scorpions to Cape Buffalo. But the splendid collection of photos of a who's who of African wildlife would have made the trip worthwhile for

almost anyone. The time in Malawi was capped off by an interpretive visit to a local village and its residents.

Terri wound up her time in Africa by visiting Capetown, South Africa.

The Masters of Nature Photography

Wayne Hall wishes to recommend this book. He writes,

“This book, first published by the London Natural History Museum in 2013, is a stunning collection of ten images each by ten internationally recognized top nature photographers. Each photograph is accompanied by several paragraphs of commentary. The ten photographers represented are Jim Brandenburg, David Doubilet, Pal Hermansen, Frans Lanting, Thomas Mangelsen, Vincent Munier, Nick Nichols, Paul Nicklen, Anup Shah, and Christian Ziegler. Some, like Lanting, Doubilet and Nicklen are well-known to many of us; some others, not so much but biographical information is provided for each.

“The majority of the photographs involve wildlife, but there are remarkable landscapes and abstracts as well. The quality of reproduction is excellent. All in all, this is one of the most inspiring nature photography collections I’ve ever seen. Several copies are available through the Minuteman Library Network, and the book

The one that I’ve described above features a widely acclaimed photograph of Polish konik horses by Jim Brandenburg on the cover.”
